WHEREAS, the Aurora Election Commission (“ELECTION COMMISSION”) is a body politic and corporate, organized and existing pursuant to the Election Code, 10 ILCS 5/1-1, *et seq.*; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Election Commission as follows:

1. That the recitals set forth above are incorporated herein and made a part hereof.
2. That the Board of Commissioners hereby approves the report of Election Judges attached hereto and incorporated herein by reference as Exhibit “A”.
3. That the Attorneys for the ELECTION COMMISSION are hereby authorized and directed to file a certified copy of this Resolution with the attached Report of Election Judges with the Chief Judge of the Sixteenth Judicial Circuit, at 37W777 Route 38, St. Charles, Illinois 60175, so that the Chief Judge may enter an order that cause be shown, if any exists, against the confirmation

and appointment of such persons so named, on or before the opening of the Court on a day to be fixed by the Court.

4. That all resolutions, or parts thereof, in conflict with the provisions of this Resolution are, to the extent of such conflict, hereby repealed.

5. That this Resolution shall be in full force and effect from and after its passage, approval and publication, in the manner provided for by law.
